## Immigration 101: Some things you should know

- Department of Homeland Security is made up of 3 agencies:
  - U.S. Citizenship and Immigration Services (USCIS): grants benefits and visas.
  - U.S. Immigration and Customs Enforcement (ICE): apprehension, detention, and removal.
  - U.S. Customs and Border Protection (CBP): apprehension at the border, designate children as unaccompanied alien children (UAC).
  - There is no INS. INS was replaced with DHS in 2003.



# Immigration 101: Some things you should know, cont'd.

- U.S. Health and Human Services, Office of Refugee Resettlement (ORR): ORR is tasked with the care and custody of UACs.
- Children who migrate alone (UACs) and children who migrate with their parents are covered by protections in the *Flores v. Reno* consent decree.
- ICE:
  - Enforcement and Removal Operations (ERO): Arrest undocumented immigrants in the interior, run immigration detention centers (including family detention centers), carry-out deportation raids. Note: These are civil arrests using warrants that do not meet 4<sup>th</sup> Amendment, U.S. Const.
  - Homeland Security Investigations (HSI): Carry out workplace raids. Also, use civil arrests using warrants that do not meet 4<sup>th</sup> Amendment, U.S. Const.
  - How can I find a person in immigration detention?
    - ICE Detainee Locator, <u>https://locator.ice.gov/odls/#/index</u>: Need Alien Number (A#), Country of Birth OR First and Last Name, Country of Birth, and Date of Birth.
- ERO has a parental rights directive, https://www.ice.gov/parental-interest.
- HSI has guidelines on humanitarian concerns but did not follow these guidelines in 2019 MS raid.



## Immigration 101: Some things you should know, cont'd.

- What about immigration court?
- Immigration Court is under the U.S. Department of Justice and is commonly referred to as the Executive Office for Immigration Review (EOIR).
- Immigration Judges are Administrative Law Judges.
- There is no right to counsel. You have to get your own lawyer (non-profit organizations or private immigration bar).
- Where a person lives may not be where a person not be where that person is detained or where their immigration court hearing is held. Example: A person may be apprehended in South Dakota (SD), detained in a federal prison in SD that has a contract with ICE in SD, but immigration court is in Fort Snelling, MN.
- How can I find information about a person's immigration case?
  - <u>https://www.justice.gov/eoir/contact-eoir</u>: Call 1-800-898-7180 to find out a person's court hearing date and court location, and case status. You need the person's Alien Number (A#) to be able to access this information.



## Recent Workplace Raids: Not all raids look alike

- Raids can look very different in size and worksite:
  - Hotel: Days Inn in Colchester, VT, 14 ICE arrests (Jan. 2018)
  - Meatpacking plant: 1 plant Bean Station, TN, 97 HSI arrests of these, 10 fed. Indictments (April 2018)
  - Garden Nursery: Garden and Nursery Center in 2 locations in OH, 114 HSI arrests (Jun. 2018)
  - Poultry processing plant: 7 plants in 7 different locations in MS, 680 HSI arrests, over 119 fed. indictments (Aug. 2019)
  - Restaurant: Indian restaurant in DC, 9 HSI arrests (July 2019)
  - Supermarket: Super Mercado Jalisco in Atlanta, GA area, 3 HSI arrests (Dec. 2019)

## Legal and Humanitarian Needs

- In first 24 hours: Does the community know who to turn to? Is there a trusted immigration community organization? What is the faith community where the community has been connected to?
- Spiritual Needs
- Language Access: Not everyone speaks Spanish. Many immigrants from Guatemala speak an Indigenous Language such as Ixil, Mam, Akateco, or Q'anjob'al as their first language.
- Immigration Representation
  - Short-term and Long-term
  - No right to counsel
- Federal Criminal Defense: Those prosecuted will be appointed a Federal Public Defender
- Civil Legal Needs:
  - Dependency
  - Family Law
  - Powers of Attorney
  - Landlord/Tenant
- Humanitarian Needs: food, clothing, utilities
- Mental Health

#### Recommendations: What You Can Now

- Create a raids response infrastructure now.
- Designate a staff member to become the in-house expert on this issue.
- Connect with your local immigration community organization now.
- Find out how local law enforcement is currently collaborating with ICE, <u>https://www.ice.gov/287g</u>
- Connect with immigration pro bono organizations, the family law bar, nearby law school clinics.
- Start working on "Know Your Rights" presentations about family law for communities so parents know what rights they have. Also, think about developmentally appropriate presentations for children.
- Advocates: Work to create "safety-plans" so there are designated responsible adults who can care for children.
